

Just to clarify the Library's position exactly with regard to the claimed ICIP of this image are you saying that:

- 1. The depiction of the three Aboriginal people in the lower left corner of the image, which I have indicated in red(see attached), is what you are classifying as "First Nations ceremonies, dance, song or other practices (whether performed by First Nations or non-Indigenous persons)"?
- 2. Are you also advising that this image "Refers predominantly to the history of First Nations people in Australia"? Given that the image "predominately refers to" the British settlement in Sydney cove, depicting British buildings, ships, and farm and town landscapes this does seem contradictory? The images of the Aboriginal people only occur in about 5 to 10% of the images area.

I would welcome you clarification on exactly what part(s) and aspects of the image fall under you r to advise categories

- 3. I have received advice that the ICIP protocols are not law in Australia they are offered as recommendations only. Could you please clarify this for me? Is it a legal requirement to obtain "community permission" or is it a recommendation only?
- 4. If permission is required, I am not qualified to know who in modern Australia would have the required status to provide that permission. Can you please advise on which modern day person or organisation has the required status to grant permission and why they have that status?

Once I receive your advice I think I will be better placed to proceed as per your quest.
