WA – East Metropolitan Health Service – CHG2024/001N



The Royal Perth Hospital Museum received \$5,500 for a Significance Assessment of the Royal Perth Hospital Museum collection.

The Royal Perth Hospital Museum (RPH) preserves and shares the history of Western Australia's longest serving hospital. The museum was established in 1979 and has built an important

heritage collection that reflects the history of the hospital operations. Through the collection, the museum reveals the journey from a desperately underfunded colonial hospital to a leading trauma and teaching hospital. They explore significant stories, people, and developments in services and facilities, and celebrate advances in health care initiated at RPH. The museum and collection are housed in the RPH Heritage Precinct, Perth CBD and is open to the public.

Participation in a significance assessment has:

- helped staff learn about their collection from the independent perspective of a highly regarded historian
- increased their appreciation and understanding of the value of the collection
- taught them the process of assessing a collection's significance
- provided short, medium and long-term key recommendations to guide future direction and contribute to long term planning and priorities for new exhibitions
- suggested new perspectives for themes and narratives including interpretation that represents the larger hospital ecosystem
- supported the curator's skill development and her confidence in leading future projects
- provided mentorship to the curator which flows onto the volunteers
- increased capacity to lobby for greater resources including additional staffing
- provided the Museum Advisory Committee and volunteers with better understanding and appreciation of the collection, and the ability to communicate this to visitors
- helped them to better care for the collection and understand our interpretation and conservation priorities.
- increased pride, commitment, and responsibility for caring for the collection from staff and volunteers.

The report will serve them well into the future and contribute to sustainability. The relationship with the consultant Dr Joanna Sassoon was collaborative, enjoyable and productive.

VIC – Australian Aircraft Restoration Group – CHG2024/003N

The Moorabbin Air Museum received \$5,570 for an updated Significance Assessment for Museum Archive.

Founded in 1962 and run almost entirely by volunteers, the Museum holds the largest and most complete collection of Australian built aircraft and engines (some being the oldest surviving or sole examples) and the biggest aviation archive collection in the Southern Hemisphere. Membership is currently 750 and annual visitation exceeds 50,000. Their goal is to preserve, display and educate the history of Australian aviation.

The Museum's last SA was conducted in 2007, followed by a PNA. However the Museum has since grown its archival collection significantly, including the recent estate donation of one person's life collection which amassed over 23 tonnes of books, reference material and photos - the single most important collection the Museum has received. Large scale donations from Boeing of technical materials, manuals and drawings, along with custodianship of the Boeing CAC collection of some 500,000 microfiche has also expanded the collection. A group of dedicated volunteers are cataloguing and uploading to the Victorian Collections site, with 15,000+ items to date.

The updated Significance Assessment was completed by their consultant Emma Russell from History at Work and the Museum now has clear guidance on the significance of the collection and steps forward to making it available and preserving it.

SA - Royal Agricultural & Horticultural Society of South Australia Archives - CHG2024/004N

The Royal Agricultural & Horticultural Society of South Australia Archives received \$5,500 for a Significance Assessment of the Royal Agricultural & Horticultural Society of South Australia Archives.

The RA&HS Archives mission is to preserve the history of the Society, Royal Adelaide Show, Adelaide Showgrounds, and the Royal Adelaide Wine Show through the retention and collection of records and items produced by, and about, these organisations and events.

They do so to promote the highly significant role the RA&HS has played, and continues to play, in South Australian culture, society, agriculture, and industry since 1839, by making the archives and museum accessible to RA&HS staff, RA&HS members, affiliated organisations, academic researchers, and the public wishing to learn about these events, organisations, and the people therein.

Kevin Jones' significance assessment report unequivocally illustrates the national significance of their collection and the value of promoting and protecting the valuable heritage collection. The noted that these findings will be shared with the stakeholders of the RA&HS of South Australia to:

- raise awareness of their collection
- promote the significance and value of their heritage collection to all RA&HS stakeholders
- lobby for greater resources for their heritage collection
- move towards greater preservation management of the heritage collection
- underpin future grant opportunities

VIC – Robin Boyd Foundation – CHG2024/011N

The Robin Boyd Foundation received \$5,500 for a Walsh Street Archive Significance Assessment.

The Robin Boyd Foundation is the custodian of the legacy of Australian modernist architect, author, critic, and public educator Robin Boyd and the iconic Walsh Street house he designed, built and inhabited.

The RBF now has contextual study of the Walsh Street Archive. The Significance Assessment helps the RBF better understand the Archive's historical, aesthetic, social and research significance and its provenance, rarity, interpretative capacity, condition, and completeness. Their significance assessment will assist them to make decisions regarding the ongoing care and conservation of the archive.

NSW – HNE Health Libraries – CHG2024/012N

The HNE Health Libraries received \$6,300 for a Significance Assessment of HNE Health Libraries Historical Collection.

HNE Health Libraries specialises in providing medical and health science information to the staff of Hunter New England Local Health District. The vision of HNE Health Libraries is to establish a

comprehensive network of health library services that provides the best available evidence to inform clinical and corporate decisions, research, innovation, education, and training throughout HNELHD.

HNE Health Libraries operates from two branches, one located at Waratah within the Calvary Mater Hospital and the other in Tamworth within the Tamworth Rural Referral Hospital. Additionally, a library office is situated within the Hunter Innovation Living Laboratory at John Hunter Hospital, emphasising the interconnectedness between the library and the health network it supports.

HNELHD serves a population of 920,370 individuals, with a specific focus on providing healthcare services to over 50,000 First Nations people. The organisation boasts a workforce of 16,000 employees and extends across 25 local government areas. Distinguished as the only district in New South Wales encompassing a major metropolitan centre, multiple large regional centres, and various smaller rural and remote communities, Hunter New England Health holds a unique position within the state's healthcare landscape. John Hunter Hospital, a cornerstone of healthcare within HNELHD, was established in 1991 through the amalgamation of four legacy hospitals. It serves as the primary tertiary referral hospital for both adult and paediatric populations. Outside Sydney is the only trauma centre in the area, making it one of the busiest hospitals in NSW.

An external consultant Dr Fiona Starr, Australian Lived Histories completed a significance assessment on the HNE Health Libraries' historical collection. Despite some challenges they found that it provided many wonderful learning opportunities. With staff especially relished the project at its closure with the culmination in the findings in the report which caused their team quite a swell of pride and emotion. It has renewed their determination to proceed with future project to their fullest extent.

NSW – Singleton Public Library – CHG2024/015N

Singleton Public Library received \$5,710 for a Singleton Library Historical Map and Area Significance Assessment.

Singleton Library was opened in 1961 and has been in its current premises for 20 years. The library holds a collection of over 45,000 items. This collection reflects the needs of the community, targeting collection development that is community needs driven. With coal mining a major employment industry in the area, Singleton has a large population of young families. There is also a strong historical community who are committed to acquiring and preserving their history. The historical collection includes collections from Council, public institutions, private companies, individuals and indigenous resources in both physical and digital formats.

The library holds a collection of area planning maps and required the expertise of a professional to determine if the collection was significant and if so, the level of that significance, that is local, state or national. They now have an excellent significance report that allows them to proceed with further management of the collection and take on the recommendations provided by their consultant.

The following recommendations were provided by Nelson Heritage Consulting:

- The maps should be catalogued in accordance with standard map cataloguing.
- Consideration should be given to digitising those items identified as of high significance.
- Advice should be sought from a conservator as to the most appropriate method of preservation and storage.

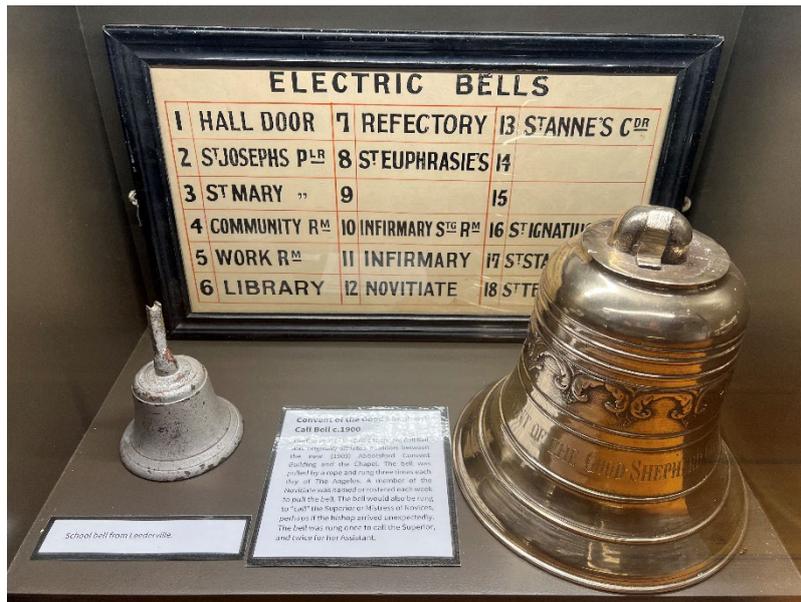

VIC – Good Shepherd Australia New Zealand – CHG2024/029N

The Good Shepherd Australia New Zealand received \$5,500 for a Significance Assessment of the Good Shepherd Archives.

Good Shepherd ANZ is a community-focused organisation dedicated to fostering economic and social wellbeing across Australia and New Zealand. Building on a legacy that began with the Sisters of Our Lady of Charity of the Good Shepherd, founded in France in 1835, Good Shepherd ANZ continues their mission of compassion, justice, and empowerment. The organisation works for justice through financial inclusion, safety, and support services. Since 1863, Good Shepherd Sisters, staff and program partners have worked across Australia and New Zealand to support women, girls and families to be safe, well, strong and connected.

This project, which was undertaken by History at Work, has provided the Good Shepherd Sisters and Good Shepherd ANZ with:

- An independent overview of the historical significance of the Good Shepherd archival collection that can guide the current and future strategic preservation decisions, associated resourcing and potential community exhibition of select materials.
- An excellent shared dialogue and potential for

further future engagement with the History At Work staff members who were sensitive to the necessary scoping parameters given the confidential nature of records held within the archival collection.

- Information and insights that may be useful in future collaborations with values aligned community organisations in order to deepen community understanding of the wider history of institutional care in Australia and Aotearoa New Zealand
- Encouragement to increase where appropriate and in compliance with privacy legislation, access to approved elements of the archival collection for academics, students, researchers, archives and museums, and other religious congregations.
- Encouragement to make carefully considered parts of the archival collection available to the public through a digital collection management system, and consider innovative options to create engaging, online exhibitions drawing on materials from the collection.

SA – National Trust of SA Willunga Branch - CHG2024/030N

The National Trust of SA Willunga Branch received \$5,500 for a Significance Assessment of Willunga Branch collections.

The mission of National Trust of South Australia (NTSA) is "Champion the preservation of South Australia's natural, built and cultural heritage for current and future generations". The NTSA Willunga Branch manage three museums and continually work to upgrade exhibitions to ensure that they are informative and engaging. They also provide a schools' program, heritage walks, an excellent research room and outreach into the community through a website, an online local history and heritage encyclopedia, and an active presence on Facebook and Instagram.

The award of the Community Heritage Grant and the subsequent significance assessment presented the welcome acknowledgement of the national significance of parts of their collection. They were able to celebrate the news of this grant on their social media, enhancing their reputation. Their consultant, Kevin Jones, also confirmed the national significance of parts of their collection. There were a few objects, however, where they had failed to recognize their significance until his report pointed it out. They found this exercise has been very useful in inspiring them to market their museum via object related web and social media posts. Their consultant also enhanced their understanding of the objects which enriched their interpretation. His report has helped them to set priorities in their Disaster Management plan. They expect the results of the assessment report to help them make future grant applications stronger.

Kevin Jones was the consultant who completed the significance assessment. All the team members who interacted with Kevin reported that they found him friendly, open and knowledgeable. He communicated clearly and was honest about his findings.

VIC – Ballarat Libraries – CHG2024/035N

Ballarat Libraries received \$6,715 for a Significance Assessment of The City of Ballarat Libraries' Rare Book Collection.

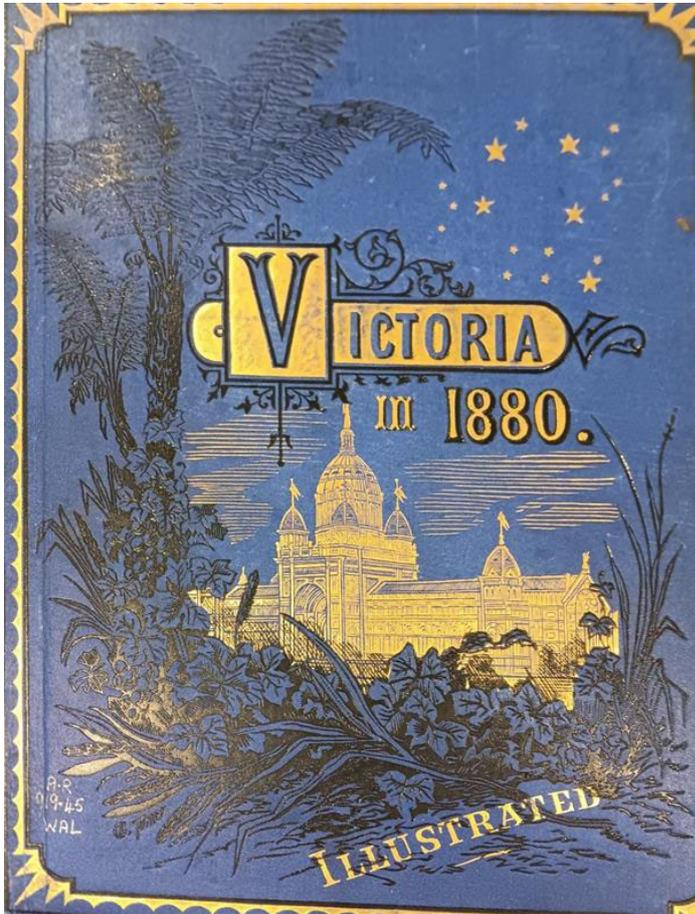
City of Ballarat Libraries manages three library branches as well as an outreach service and a research hub located within Eureka Centre museum. The service provides a range of diverse, contemporary public library services and programs. The service supports a rapidly growing

community in regional Victoria and supports a broader network of public libraries across the Central Highlands area. Ballarat public libraries have a long history, dating back to the Gold Rush era. Many volumes from this time have survived and can be found in our rare book collection today.

This project has allowed them to understand and contextualise their rare book collection. Through expert assessment, the consultants have provided a basis for comparison with similar collections in similar institutions and confirmed their thoughts around the significance and uniqueness of this rare book collection. This project has given a path for future actions and clear direction looking forward in the areas of conservation, preservation and access- including opportunities to engage the community with the collection through exhibitions and programming. The assessment recommends the development of several guiding documents to help them in better managing the collection, and it assists with the development of a clear definition of what constitutes a rare book in their collection context. They were pleased with the consultant History at Work Emma Russel who they engaged and felt they brought experience and expertise to the project while at the same time allowing them to clearly define what they hoped the project would achieve. They are now better positioned to advocate for this collection and to lobby for increased



resourcing - as they are equipped with the expert assessment of what is required to both safeguard this collection for the future, and to make it accessible and celebrated in our community.

WA – Albany's Historic Whaling Station – CHG2024/039N

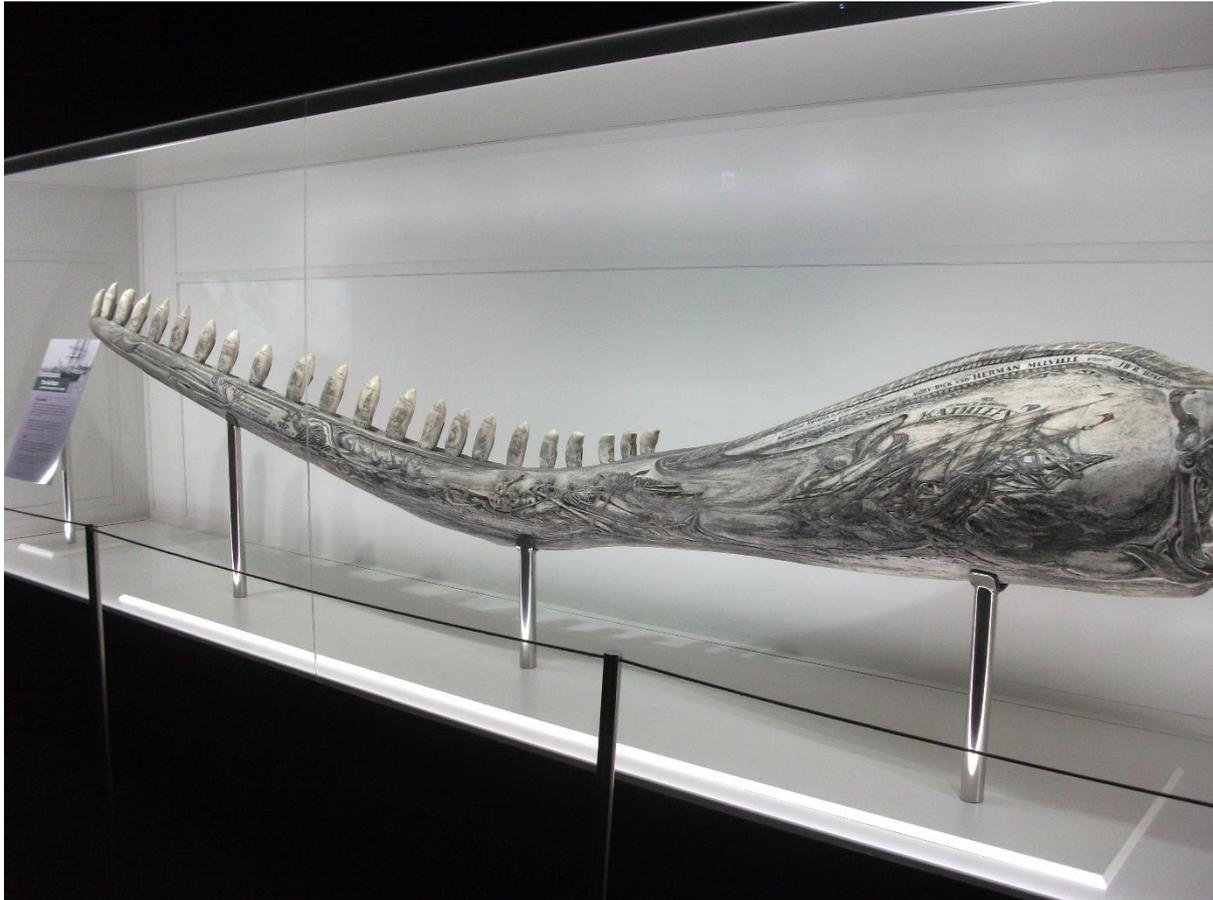
The Albany's Historic Whaling Station received \$8,542 for a Significance Assessment of Albany's Historic Whaling Station Collection.

The Cheynes Beach Whaling Company operated from 1952 until 1978. In 1980, the site was transformed into a museum, now known as Albany's Historic Whaling Station (AHWS). AHWS offers a unique maritime museum experience and stands as a premier heritage tourist attraction in the region. As custodians of Australia's whaling legacy, they bring Albany's whaling history to life, offering visitors immersive experiences and learning opportunities through engaging with the

authentic infrastructure and artefacts, including an original whale chasing vessel. Their programs encompass heritage conservation, exhibition development, collections management, tours, “meet a former whaler” program, regional arts events, and school holiday activities.

The project successfully achieved its aims of evaluating the historical, cultural and social significance of their collection. They now have a clearer understanding of the collection’s value, its key themes and stories, and preservation priorities. This new knowledge has already informed these priorities, with recommendations guiding future conservation and improved storage conditions. The project has paved the way for a much-needed preservation needs assessment, which will guide practical strategies for stabilising and caring for some of the more complex items requiring specialist expertise.



The project also delivered broader organisational benefits: upskilling of archives staff in preservation methods; strengthened awareness of national standards for collection care; deeper knowledge of the breadth and depth of the collection; new networks and professional relationships; stronger commitment from executive management; and increased capacity to apply for targeted conservation funding. This positions us to more effectively safeguard our unique maritime heritage.

The assessor’s expertise (Kris Bizzaca) supported a collaborative process that encourages learning, open discussion and practical decision-making. Although unforeseen family circumstances resulting in challenges for the assessor to maintain momentum and meet reporting timelines, Discovery Bay is very satisfied with the working relationship and final report, which provides a strong framework for future planning, action and resource advocacy.

VIC – Bendigo District RSL Sub-Branch INC – CHG2024/040N

The Bendigo District RSL Sub-Branch Inc received \$5,600 for a Significance Assessment of the Bendigo Military Museum collection.



The Bendigo Military Museum, housed in the iconic heritage-listed Soldiers Memorial Institute, preserves and shares the military heritage of Bendigo and its surrounding region. It showcases personal stories, artefacts, and memorabilia from the Boer War to contemporary peacekeeping operations, highlighting the experiences of local servicemen and women. A key regional institution, the museum fosters community engagement, remembrance, and education. Recent initiatives, including

a significance assessment and new interpretive displays, have strengthened its role as a vibrant, accessible place of learning and commemoration. The museum is operated by dedicated staff and volunteers, under the umbrella of the Bendigo District RSL.

The Bendigo Military Museum's Significance Assessment (undertaken by Dr Megan Cardamone from Circa Museum Services) achieved important outcomes across multiple areas:

- It developed the skills of staff and volunteers by providing hands-on experience in object research, significance analysis, and condition reporting. Staff and volunteer commitment was reinforced through their active involvement and a growing sense of ownership.
- Preservation of the collection was enhanced through better understanding of conservation priorities, enabling more informed decisions about storage and handling, and building conditions were assessed, providing a strong foundation for future upgrades.
- Knowledge of the collection deepened considerably, with new connections identified between objects and broader historical narratives, with detailed object histories and significance ratings now available to guide interpretation both in the museum and online.
- The findings in the Significance Assessment have provided the groundwork for future projects, with the assessment enhancing their capacity to advocate for increased resources by producing a professional, independent report to support grant applications and strategic planning.
- Lastly, the project strengthened networks within the cultural heritage sector by engaging professional consultants and aligning practices with national standards, and we enjoyed an excellent relationship with their consultant, who was highly responsive, producing a thorough, insightful report that will guide their collection management for years to come.

QLD – Woorabinda Aboriginal Shire Council – CHG2024/044N

The Woorabinda Aboriginal Shire Council received \$10,022 for a Woorabinda Cultural Heritage Collection Project.

The Woorabinda Indigenous Knowledge Centre is a library funded by the State Library of Queensland through a Service Level Agreement with the Woorabinda Aboriginal Shire Council.

Woorabinda is in Central Queensland, south-west of Rockhampton and south of Duarina. It is on the traditional lands of the Wadja and Gunghalu Peoples.

Woorabinda residents speak English with some speaking both English and an Aboriginal language. There are approximately 52 clans represented in Woorabinda, with a number of language groups from across Queensland.

Indigenous Knowledge Centre (IKC) staff are employed by Council. IKC staff provide the community with access to collections, information and resources.

Outcomes of project:

- Sophie Price from Queensland Museum Development Officer Network, conducted a Significance Assessment on the collection
- Skills development: the project has been undertaken with people who specialize in this field. Additional training is needed for staff to manage the collections.
- Preservation of the collections are in good condition, though future care of them is needed for prosperity.
- Access: The collection is available on request. The online collection is being developed by digitising all original material and will take time to complete.
- Knowledge of Content is built around current collection, memories of Elders in Woorabinda and Auntie Diane Hill's contribution that deserves recognition.
- Their rapport with other IKCs, SLQ and the QM, enables their collection to be an example of what we can do showcasing First Nations history in Australia and provide further opportunities for additional collaborations and exhibitions.
- They can now develop a Preservation Needs Plan for the collection.
- Storage is basic but they have purchased some archival storage boxes and tissue interleaves for immediate remediation and will need specialized equipment and training for proper protection.
- They have begun cataloguing the collection in preparation of acquiring an e-Hive Collection Management or equivalent.
- Council has capacity to lobby for more resources and staff if needed.

The Mansfield Historical Society Inc received \$6,400 for a Significance Assessment of the History of the Forestry Industry in Victoria.



The Mansfield Historical Society (MHS) has been in existence for more than 50 years for the aim of preservation and promotion of the history of Mansfield and surrounding districts. The Society's collections contain a wealth of information about the history of Mansfield and the surrounding district including genealogical information, microfiche documents, photo, memorabilia, maps and an extensive clothing collection.

A new Mansfield Historical Museum building, now completed externally, commenced construction in March 2024 and is in the process of being fitted out for display and exhibition.

This project has helped in bringing together two collections of material (plus additional material in an archive) relating to the Forestry Industry in Victoria in the past 100-plus years, into a single collection, part of which will be able to be presented in a public display. The collections consist of documentary material such as maps,

record books and photographs mainly in hard copy form, as well as various artefacts such as old work tools, axes, early chainsaws and clothing.

The whole collection, when combined, is able to be stored appropriately in the storage facilities in the new Museum building to be operated by the Mansfield Historical Society. The significance assessment was conducted by Emma Giessmann.

WA – Edward de Courcy Clarke Earth Science Museum – CHG2024/061N

The Edward de Courcy Clarke Earth Science Museum received \$7,975 for a Significance Assessment of the E. de C. Clarke Museum’s Earth Science Research Collection.

The Edward de Courcy Clarke (EdCC) Earth Science Collection, housed within the University of Western Australia’s School of Earth Sciences, represents over a century of geological education, fieldwork, research, and public engagement. The EdCC Collection comprises more than 183,000 registered specimens and a substantial number of unregistered materials, including rocks, minerals, fossils, meteorites, petrographic slides, teaching sets, archival photographs, theses, and field notebooks. The collection reflects the deep geological history of Western Australia and the legacy of key figures such as Edward de Courcy Clarke, Curt Teichert, Basil Balme, and Professor David Haig.

The Community Heritage Grant enabled the Edward de Courcy Clarke Earth Science Museum to commission its first formal significance assessment, conducted by Erina McCann (Tiaki Objects Conservation) in 2025. The project has greatly strengthened their understanding of the collection’s national and international importance, clearly articulating its historic, scientific, and social value. It has also identified urgent preservation needs and provided a strategic framework to guide future collection care, cataloguing, digitisation, and storage improvements.

Through this process, staff and volunteers have gained new skills in heritage assessment and collection management, while the report itself has improved institutional knowledge of the breadth and depth of the collection. The findings raised the profile of the museum within the University and the broader heritage sector, enabling stronger advocacy for resources and increased visibility in the community. Importantly, the assessment confirmed the collection’s continuing role in research, education, and outreach, while highlighting risks such as hazardous materials and inadequate storage.

The comprehensive report provides a robust foundation for building partnerships, securing resources, and ensuring the long-term preservation and accessibility of one of Western Australia’s most significant Earth Science collections.

Wallangang Aboriginal Corporation and Randwick City Council received \$9,721.82 for a Timbery Family Collection - Significance & Assessment.

The La Perouse Museum, located in the historic La Perouse precinct on Sydney's southern headland, is dedicated to exploring the area's rich cultural and natural heritage. Housed in the heritage-listed Cable Station building, the museum tells the story of French navigator Comte de Lapérouse's 1788 expedition, as well as the deep and ongoing connection of the local Aboriginal community to the land and sea. Through exhibitions, collections, and public programs, the museum highlights themes of exploration, encounter, and exchange, celebrating La Perouse as a place where Aboriginal, European, and Asia-Pacific histories intersect and continue to shape the present.

In 2024, the Wallangang Aboriginal Corporation, in partnership with the La Perouse Museum and supported by the Powerhouse Museum, completed key preservation and cataloguing activities for the Timbery Family Collection — a significant archive of cultural artefacts, photographs, manuscripts, and artworks spanning generations. The collection was safely relocated to the La Perouse Museum, where an intensive cataloguing workshop was conducted. With guidance from Indigenous Collections specialists, led by Matt Poll from the Australian National Maritime Museum, a Significance Assessment was completed, confirming the national importance of the collection.

The collection was re-housed using museum-grade archival materials and stabilised for long-term storage. These activities have ensured the safeguarding of this unique cultural legacy while maintaining family custodianship and cultural control. The project has also laid the groundwork for future digitisation, public access, and exhibition opportunities, continuing the success of the *Joe Timbery: World Champion Boomerang Thrower* exhibition presented at the La Perouse Museum in 2024.

Mulberry Hill was the home of Daryl and Joan Lindsay for over 50 years. Joan was an artist and writer whilst Daryl was an artist, Director of the National Gallery of Victoria and founding president of the National Trust. The site preserves original buildings in bush-land surroundings. The house is highly significant as it contains the Lindsays' respective studios: the rooms where Joan's classic Australian novel *Picnic at Hanging Rock* was written and where Daryl's artworks and studies were completed, including subjects such as the Ballets Russes in Australia. The house and contents were gifted to the National Trust and the interiors are original to the Lindsays' occupation.

The Mulberry Hill Preservation Needs Assessment assist staff and volunteers to care for and interpret the collection. It has provided the National Trust with clear recommendations for conservation works to objects, building maintenance, environmental controls, and pest management. These recommendations have also been broken down into short and long term categories allowing the Trust to prioritise work and applying for funding via grants and philanthropic donations to do these works. Ethnic Community Broadcasting Association of Victoria Limited received \$5,500 for a Preservation Needs Assessment.

The Ethnic Community Broadcasting Association of Victoria Ltd (3ZZZ) has been operating since 1989. 3ZZZ gives voice to ethnic communities, broadcasting in their own languages. 3ZZZ is Australia's largest multilingual community radio station represented by over 60 language/community groups, 120 programs, 400 volunteers, 3,000 members and 400,000 listeners.

3ZZZ's history began in the 1950s with the commencement of the post-World War 2 mass immigration program, as migrants became conscious of their position as permanent residents in Australia.

Movements such as the Migrant Workers Committees, Migrant Education Action and Ethnic Communities Councils and other alliances were forming, seeking democratic reforms on principles of multiculturalism, and the dismantling of the White Australia policy.

In 1973 the Whitlam Government adopted its policy on multiculturalism. At the first Migrant Workers Conference in 1973, attendees demanded the ABC amend its charter to incorporate multiculturalism, and the Federal Government establish and support ethnic broadcasting services, managed by elected members of migrant communities. This led to the establishment of 3ZZ Access Radio under the auspice of the ABC and commenced the rich history of the broadcaster, that continues to this day.

A report on the preservation needs of the multilingual collection of historical materials was conducted by Grimwade Conservation Services. This collection was deemed nationally significant by a previous assessment.

The Ballarat Mechanics' Institute received \$6,700 for a Preservation Needs Assessment of the Ballarat Mechanics' Institute Heritage Registered Collection.

The Ballarat Mechanics' Institute has welcomed a diverse group of people through its doors since 1859, from the founding fathers, to miners, tradespeople and others seeking knowledge through education. In the days before Government funded libraries and adult education, the Mechanics' Institute provided people with much-needed access to books, newspapers, periodicals, lectures and scientific demonstrations and provided local communities with a place for social, cultural and recreational gatherings.

Today they have a lending library, historic books and newspaper collections, research facilities and regularly host live music, plays, literary events, talks and community recreation activities including arts and culture festivals.

A previous Preservation Needs Assessment was completed in 2008 and was a very useful document, with many areas of need identified and now completed.

Naturally many of the remaining recommendations needed fresh appraisal, due to time and changes in collection management policy, best practice and resources available; many new issues have come to light through this new PNA.

Having recently completed new Significance Assessment with thanks to a previous CHG Grant, members were keen to understand their next steps in caring for their collection and be able to prioritise those actions through the PNA. This has added weight to funding applications or philanthropic support to complete future works.

Their collection is very extensive, has many facets and still needs much conservation work and ongoing care, so this professional and guiding document is essential to assist them to move forward, and to enable a strategic and focussed approach to project identification and management and ultimately to enable their wonderful collection to be more accessible to a much wider audience in a

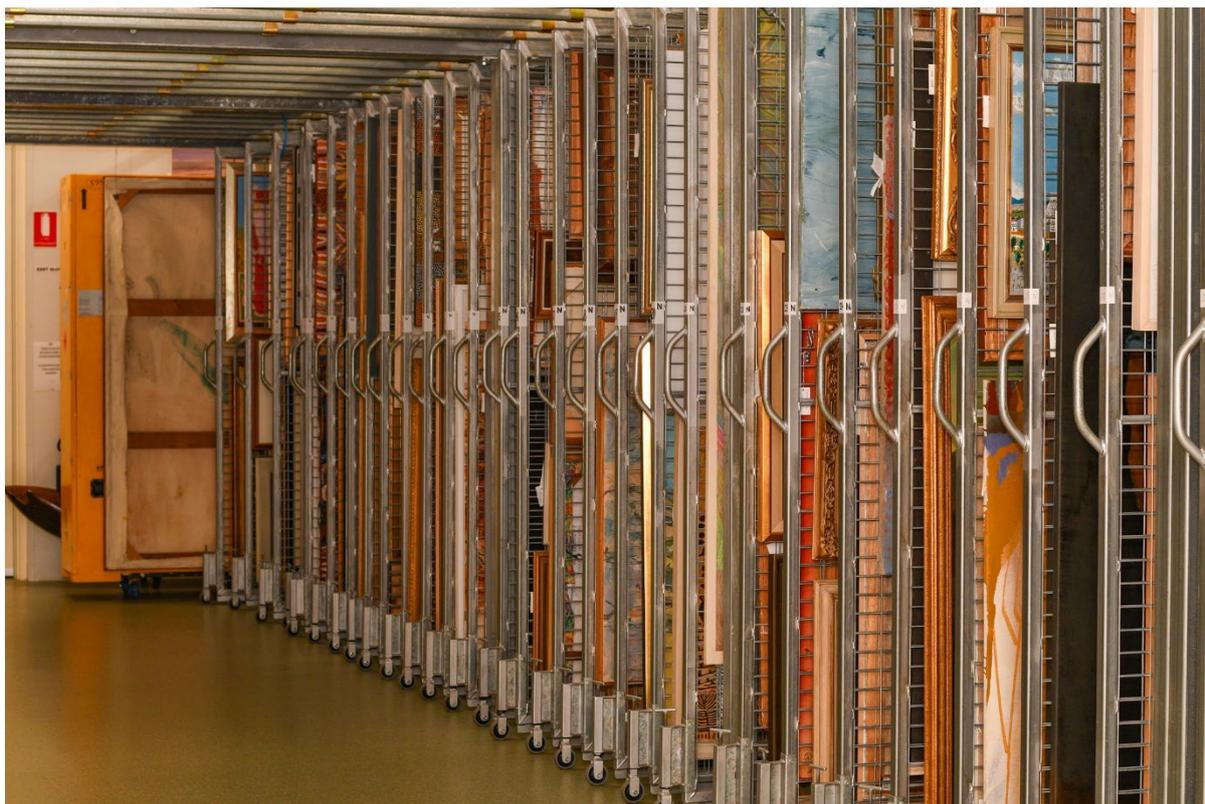
NSW – Broken Hill City Art Gallery – CHG2024/038R

Broken Hill City Art Gallery received \$7,841 for a Preservation Needs Assessment.

Broken Hill City Art Gallery is the oldest regional art gallery in NSW, having opened in 1904 and relocating in 2004 into the beautifully restored 19th-century Sully's Emporium.

The Gallery showcases a rotating programme of exhibitions spanning 19th-century colonial works, modern and contemporary Australian art, and Indigenous art featuring artists like Margaret Preston, Arthur Boyd and Clifford Possum Tjapaltjarri. Local and regional artists are also represented, including work by Sam Byrne, William 'Badger' Bates, Jim Paterson and Pro Hart. The Gallery has a quality program of temporary exhibitions by local, state and national artists along with touring exhibitions.

Undertaking the Preservation Needs Assessment (by consultant Tegan Anthes) has delivered valuable outcomes for the Broken Hill City Art Gallery and its nationally significant collection. The assessment provided a comprehensive overview of the condition of artworks, objects, and storage environments within the heritage-listed Sully's Emporium building. It identified areas of strength in the Gallery's existing practices and outlined specific priorities to improve the long-term care and conservation of the collection.

The PNA has enabled the Gallery to adopt a more strategic approach to preventive conservation, ensuring that environmental conditions, storage, handling, and display practices align with current museum standards. Recommendations have informed the development of updated policies and procedures, strengthened risk management, and supported staff capability in collection care and documentation.

Importantly, the assessment has provided an evidence-based framework for future investment and resource planning. It positions the Broken Hill City Art Gallery to seek targeted funding and partnerships to implement key preservation improvements. The outcomes of the PNA contribute directly to the Gallery's mission to protect and present its collection for the benefit of the Broken Hill community and visitors, ensuring the sustainable preservation of one of New South Wales' oldest and most significant regional art collections.

TAS – Mawson’s Huts Foundation – CHG2024/043R

The Mawson's Huts Foundation received \$5,500 for a Mawson's Huts Replica Museum Preservation Needs Assessment.

The Mawson’s Huts Foundation is a not-for-profit charity established in 1996 to conserve the historic huts at Cape Denison, East Antarctica, which were used by the 1911–14 Australasian Antarctic Expedition (AAE) led by Sir Douglas Mawson. In 2013, the Foundation opened the Mawson’s Huts Replica Museum to help raise funds for the ongoing conservation program. The museum, just 200 metres from where the AAE departed in 1911, is rated as the No.1 museum in Hobart.

The Preservation Needs Assessment, undertaken by Michelle Berry Heritage Preservation, provided recommendations to improve the long term preservation of the collection in the Mawson's Huts Replica Museum. This included environmental monitoring which determined that the environment with the museum is within the recommended guidelines.

Other recommendations included the preparation of a disaster plan, the establishment of a pest inspection program, upgrade to lighting to enable to control light levels of object exhibition, training of staff in object handling and pest monitoring and appropriate cleaning methods for collection items.

in churches, schools, prisons and hospitals. The diocesan archive preserves the permanent records of Anglican church life and contributions to community, townscapes, culture and life in SA and beyond.

Their project achieved completion of a Preservation Needs Assessment, addressing the needs of their extensive collection. They worked with consultants at Artlab SA who produced the report for them.

On the strength of this report the Archives Office hope to lobby for increased resources, and undertake the most pressing actions to benefit their collections, preserve them and increase access. This will assist with their collection's visibility within the history / heritage community, the church community and indeed the wider community.

The Archives Office has appreciated the opportunity to build networks with Artlab and enjoyed a happy working relationship with them. Their staff and volunteers were left with a stronger knowledge of our collections and increased commitment to the cause of caring for them.

NSW – Cowra Japanese Garden and Culture Centre – CHG2024/003R

The Cowra Japanese Garden and Culture Centre received \$12,439 for Preservation of Display Items – Shoji Screens and Display Cabinets.



The Cowra Japanese Garden and Cultural Centre is a not-for-profit organisation and represents post WWII reconciliation between Japan and Australia. Their Garden is a living symbol of friendship and empathy, encouragement of understanding and peace. Their garden has been described as the home of Japanese Culture in Australia as well as the largest Japanese Garden in the Southern Hemisphere. It also pays respect to the Prisoners of War from the Cowra POW Breakout from 1944.

They also have a vast Japanese Cultural Collection displayed on rotation in our Cultural Centre. Items include ceramics, clothing, sculptures, paintings, scrolls and wartime relics.

Upgrading the display cases has significantly enhanced public access to the collection, enabling the rotation of a greater number of items and improving conditions for displaying cultural artefacts. These advancements allow for extended exhibition periods while ensuring the preservation of the artefacts.

Regular preservation and cleaning are now more efficiently managed by a single staff member, as the cabinets with heavy and fragile doors that previously required multiple personnel have been replaced. Additionally, pest management has been simplified due to the removal of the organic fabric bases beneath displayed items.

Storage conditions have also been optimised, with convenient access to storage compartments located beneath the display units. Furthermore, the installation of LED lighting within the units has elevated the display standards to meet professional and museum-quality benchmarks, aligning with the objectives of our Cultural Centre.

NSW – National Trust of Australia (New South Wales) Miss Porter's House – CHG2024/005R

The National Trust of Australia (New South Wales) received \$8,541 for Conservation and Collection Management Activities Miss Porter's House.

The National Trust owns and manages a number of heritage properties, including Miss Porter's House in Newcastle West.

This is an Edwardian terrace house museum, owned and lived in by the Porter family from 1910 until 1997. The house is the only National Trust property in Newcastle and has over 5,000 objects in its collection. This includes documentary heritage items which are listed on the UNESCO Australian Memory of the World Register.

Conservation of the house and its contents has been a major focus particularly in recent years with funding from State and Commonwealth governments.

All three project activities have been completed:

- The installation of block out blinds to help control temperature and light. Both these issues were identified as priorities in the Preservation Needs Assessment.
- Purchase of a data logger to measure and record environmental conditions in the house and help us determine the best location of objects for their conservation.
- Conservation of documents.

The blinds are only open when there are people in the house, the data logger is regularly monitored and results discussed at the management committee meetings and the documents are conserved and appropriately stored and available for display.

The Maritime Museum of Tasmania Inc received \$1,135 for a Collection Management activity the enhanced archival storage of eighteenth and nineteenth century works on paper.

Its collections form Tasmania's most significant maritime heritage resource. Today, the Museum sustains a lively network of volunteers, researchers and maritime enthusiasts, connecting community and history through exhibitions, programs and collaborations across Tasmania and beyond.

The project successfully rehoused some of the Museum's works on paper (ship portraits, maps and related material) into appropriate archival storage. Items that were still in frames were carefully removed, condition-checked, and placed in archival boxes. This work has greatly improved the preservation of the collection and reduced risks associated with handling and poor housing. The project also strengthened the Museum's understanding of the collection's condition and informed priorities for future conservation planning.

SA – Flinders University Museum of Art – CHG2024/013R

Flinders University Museum of Art received \$18,182 for a Digitisation of at-risk magnetic media.

Flinders University Museum of Art (FUMA), established in 1978, cares for and develops a collection that has been growing since 1966. Key strengths include Contemporary Aboriginal and Torres Strait Islander art, European prints, Post-object and documentation art, and Australian political prints and posters, alongside smaller collections of Australian, international and Japanese works. FUMA plays an active role in university life, using its collection to support teaching, research and object-based learning across disciplines. It engages students, staff and researchers in critical discussions about art, culture and history, and provides access through exhibitions, programmes and an online catalogue.

Phase two of FUMA's media digitisation project has been successfully completed, securing the preservation of their most fragile and at-risk holdings. The project prioritised EIAJ open reel video recordings, which were especially vulnerable due to their rarity, fragile consumer-grade format, and the scarcity of playback equipment. Working with DAMsmart, these works have now been digitised to IASA TC-06 standards, creating both high-quality archival masters and accessible viewing copies.

The digitised collection captures significant documentation of Australia's post-object and conceptual art movement, spanning 1966 to 1985. This includes unique works by artists such as Joseph Beuys,

David Malangi, Charles Simonds and Tim Burns, whose experimental practices were recorded on early video. Through this project, materials that faced imminent loss have been stabilised and safeguarded, ensuring they remain available for future generations of researchers, artists, and the broader community.

Additional magnetic media and film were also digitised to support current research, demonstrating the collection's value as a resource for postgraduate study. All original carriers have been rehoused in archive-quality storage, while the digital files are securely stored in multiple formats and locations. This outcome strengthens FUMA's ability to provide long-term access to nationally significant media art.

SA – Shoalhaven Historical Society Inc – CHG2024/014R

Shoalhaven Historical Society Inc received \$16,579 for a Conservation Condition Assessment of Elyard Art Collection.

Shoalhaven Historical Society was formed in 1967. In 1980 SHS established a museum in the former police station. SHS actively seeks objects from the public and regularly attends A & H shows, Expos and fairs to encourage people to participate in the heritage of the Shoalhaven. They also host numerous visits from school children and groups and provide guest speakers. They undertake research for private and government agencies and publish an extensive array of books and pamphlets, written by our members. They are actively involved in the struggle to retain items, precincts and buildings of heritage significance from "redevelopment".

This project consisted of two parts. Part 1 provided for a Condition Assessment Report of the 62 paintings by Samuel Elyard which are in the collection of Nowra Museum. This assessment was undertaken by conservator Kristel Smits in January 2025. Kristel closely examined each painting using lights and other equipment and provided a Conservation Assessment including: a photograph for each painting; details of dimensions, medium and framing status; a detailed condition report; and detailed recommendations for treatment. This Condition Assessment is proving invaluable as volunteers endeavour to take responsible action to ensure the integrity and longevity of such a large collection of Samuel Elyard works. The conservator has indicated those works most at risk which has enabled us to draw up a priority list for treatment.

Part 2 consisted of two x three hour workshops designed to assist the entirely volunteer workforce in caring for the important Samuel Elyard Collection. The workshops were attended by six enthusiastic volunteers. They learned correct handling procedures for artworks, to identify problems such as incorrect framing, mould issues, problems with stretchers failing, and water damage. Acceptable conservation standard storage was also addressed and they learned to make archival quality folders.

NSW – Georges River Council – CHG2024/030R

Georges River Council received \$13,230 for conservation training, cleaning and archival rehousing of local studies document- based collections.

Georges River Council (GRC) was proclaimed on 12 May 2016, amalgamating Hurstville City Council and Kogarah City Council. GRC now provides five public libraries in the Georges River Area. Both former councils maintained local studies collections that now create the Georges River Libraries Local Studies Collection.

The collection preserves the region’s heritage through oral histories, texts, and photographs and is accessible at both Hurstville and Clive James Kogarah Libraries. The museum and library teams maintain and expand the collections, documenting the community’s diverse stories, supporting public access to local history and strengthening cultural preservation across the Georges River area. The conservation and archival rehousing project has significantly increased the level of preservation of their archive collection material, the detailed knowledge of the collection’s content and developed staff practical conservation skills.

Over the past eight months, the project has significantly improved the care, accessibility, and understanding of their archival collection. A total of 1,222 items, including books, photographs,

documents, ephemera, glass plate negatives, and small objects, were rehoused using archival-grade materials, enhancing their physical stability and longevity.

Through this project staff also deepened their knowledge of the collection's content, uncovering provenance and historical connections that enrich their understanding of local heritage. As a result, access to the collection has been significantly improved; items are now safely housed, clearly labelled, and easier to retrieve, supporting future handling for research, exhibitions, and community engagement, as well as digitisation opportunities. Additionally, staff created new catalogue records with detailed indexes of each item, making the archive collection searchable for the community for the first time.

Staff developed practical conservation skills through training and hands-on experience (delivered by Tegan Anthes), including cleaning techniques, object handling, and custom housing construction. Team members reported increased confidence in object handling and care, applying best-practice methods and solving complex conservation challenges.

NSW – Tranby Aboriginal Co-operative Limited – CHG2024/031R

Tranby Aboriginal Co-operative Limited received \$9,500 for a project titled Preserving and Safeguarding Tranby's nationally significant Indigenous collections.

Established in 1957, Tranby Aboriginal Co-operative Limited (Tranby) is Australia's first and longest-running independent Indigenous education provider. They are an Aboriginal-controlled non-for-profit providing cultural support and value to the local and national Indigenous and non-Indigenous community.

Based in Glebe, NSW, Tranby is a Registered Training Organisation (RTO) providing nationally accredited Diploma and Certificate level courses to Indigenous adults. As a community organisation Tranby is an important place of culture and community connection for our Indigenous community.

Tranby has successfully completed the design and implementation of their Mukurtu instance, now securely hosted within the Digital Dilly Bag—Tranby's sovereign data centre. This milestone ensures that Tranby's digital collections and cultural knowledge are managed in a culturally safe, community-controlled environment, with all data remaining on infrastructure owned and governed by Tranby.

The Mukurtu platform, purpose-built for Indigenous communities, enables Tranby to manage, share, and protect digital content according to cultural protocols and community preferences. By integrating Mukurtu within the Digital Dilly Bag, Tranby strengthens its commitment to Indigenous data sovereignty, digital self-determination, and the respectful stewardship of cultural heritage.

This implementation positions Tranby as a leader in the use of digital tools for cultural preservation, ensuring that First Nations knowledge remains protected, accessible, and governed by community-defined values.

NT – Ngurratjuta/Pmara Ntjarra Aboriginal Corporation – CHG2024/032R

The Ngurratjuta/Pmara Ntjarra Aboriginal Corporation received \$17,190 for conservation treatments for the Ngurratjuta Collection.

Ngurratjuta/Pmara Ntjarra Aboriginal Corporation was incorporated in 1985 under the Aboriginal Corporations Act of 1976, as an association of communities “affected” by oil/gas operations at Mereenie and Palm Valley. Ngurratjuta provided a mechanism for receipt and distribution of statutory royalties payable to these affected Communities under the *Aboriginal Land Rights (Northern Territory) Act 1976*.

Ngurratjuta’s purpose was to support independent Aboriginal Communities through building an investment base to protect accumulated royalty funds through investment, whilst stimulating employment opportunities and venture activities, supporting development in Member Communities.

One of Ngurratjuta's key investments has been acquiring art significant to the Ngurratjuta Region.

The CHG grant project this year has achieved a full and thorough condition assessment of 45 Albert Namatjira original watercolours owned by Ngurratjuta.

Through delivering a comprehensive assessment of the works, the consultant Artlab Australia were able to provide detailed and informed recommendations for conservation treatment, with recommendations tailored to fit the specific needs of each work. This substantive review, assessment and recommendation process has enabled Ngurratjuta to fully understand the condition of each of the key works in its collection.

A small amount of conservation treatment has also been delivered under the funds provided.

Aside from the key deliverables under the quote, skills and knowledge of Ngurratjuta's Curator have been developed as a result of working closely with Artlab Australia.

The Nutcote Trust Pty. Ltd received \$13,545 for a Preserving May Gibbs' Nutcote Collection project.

The Nutcote Trust is dedicated to preserving and sharing the legacy of May Gibbs, one of Australia’s most beloved authors and illustrators. It manages Nutcote, May Gibbs’ historic home and studio in Sydney, ensuring the property, its gardens, and her collections are maintained for public enjoyment. The Nutcote Museum, operated by the Trust, offers visitors an immersive experience into May’s creative world, showcasing original artworks, personal memorabilia, and insights into her life. Through exhibitions, educational programs, and community events, the Trust and Museum celebrate May Gibbs’ artistic achievements while inspiring appreciation for Australian literature, art, and cultural heritage.

The Preservation Needs Assessment, by Tegan Anthes, has provided clear and practical guidance for preservation planning based on the current condition of the Nutcote collection. To date, the report



has been an important resource in the development of new collection policies and has informed restoration works undertaken on items with confirmed provenance to May Gibbs.

A comprehensive data clean of the existing collection Excel spreadsheet has been completed. Duplicate records were identified and removed, and a new standardised numbering system has been introduced. Collection items have been photographed, with images accurately labelled to match records, and resized to maximise digital storage efficiency.

This work has enabled the successful transfer of collection data into the new collections management system, eHive. Records are currently private while

public descriptions are being completed. Once published, the Nutcote collection will be searchable alongside May Gibbs collections held by other organisations, creating a single access point for the nation's May Gibbs collections outside the State Library of NSW.

Volunteers have been actively involved throughout the process, building skills and confidence in the professional handling, documentation, and care of collection items.

QLD – QLD Braille House (formally known as Queensland Braille Writing Association) – CHG1024/039R

Braille House (formally known as Queensland Braille Writing Association) received \$7,900 for a Conservation and Collection Management of Braille House Items of Significance.

Since 1897, Braille House has produced high-quality Braille materials. As a lending library and transcription service, they convert text into Braille, eBraille, Moon, large print, audio, and tactile formats. They create accessible resources like menus, health info, maps, emergency plans, and newsletters. Their work supports projects such as the National Bowel Screening Program, Cross River Rail, QAGOMA, various government and council initiatives, as well as businesses and individuals.



They also offer expert Braille tutoring to people who are blind or vision impaired, their families, and carers. Our services are delivered by a small team and nearly 60 dedicated volunteers.

There were three main objectives to Braille House's "Collection Rehousing and Storage" project.

1. To sort, clean and store the collection, with assistance from the CHG to purchase archival storage and materials; sorting and cleaning the collection has begun, with archival materials purchased. This is an ongoing project, that will contribute to the long-term protection of the collection. One outcome has been the identification of significant items that were previously unknown to the organisation.
2. Training in preventative conservation; a workshop on preventative preservation, run by consultant, Christine Ianna, was held in August 2025, and attended by staff, volunteers and members of the Yeronga Historical Society (to foster relationships with the local community). The workshop covered preservation methods and raised awareness of how these methods can assist with avoiding problems identified in Braille House's Preservation Assessment.
3. Create a Disaster Preparedness Plan; Christine assisted in developing an Interim Collection Management Policy and, from there, an Interim Disaster Preparedness Plan. Both can be temporarily used to guide management of the collection, until the Management Committee can ratify the policies, noting they will need to be further developed.

VIC – Australian Queer Archives Inc – CHG2024/040R

The Australian Queer Archives Inc received \$17,400 for a Bill West Community Radio Collection Digitisation Project – Part 2.

The Australian Queer Archives (AQuA) is a community-based, volunteer-run, and member-funded not-for-profit organisation, established in 1978. AQuA was initially known as the Australian Gay Archives (1978-1992) then Australian Lesbian and Gay Archives (1992-2020). Since its inception, they have developed the world's largest and most significant archival collection of Australian LGBTIQ+ material. They make the collection accessible to researchers, cultural institutions and all others wanting to learn more about the LGBTIQ+ communities.

AQuA has an active member, volunteer and community profile, regularly working with a range of institutional and event partners across local, national and international forums.

The Bill West Community Radio Collection Digitisation Project – Part 2 digitised the remaining 145 ¼" reels that were not undertaken in the previous CHG activity. Preparatory work included: collection audit; pre-digitisation condition assessment; and digitisation quote selection. Delivery included digitisation of the 1/4" reels in two batches through the selected digitisation company, quality checking and backing up files, including Broadcast WAV Preservation Master files, and MP3 Access files. Detailed cataloguing of the contents has commenced, ensuring significantly improved access to the collection. Volunteers are in the process of finalising their purchase of a collection management system (CMS) and are aiming to have the records for their audio collection, including those relating to the Bill West Collection, available online in 2026, and then harvested and accessible on Trove.

Duldig Studio received \$1,799 for preventive conservation of drawings, ephemera and ceramics.

The Duldig Studio is a public house museum, art gallery and sculpture garden located in East Malvern, Melbourne, and the former home and studio of internationally recognised sculptor Karl Duldig (1902-1986) and his wife, artist and inventor Slawa Duldig (1902-1975). The organisation's vision is to be recognised as a pre-eminent Australian artists' house museum that inspires, informs and engages through art and the story of the Duldig family's creative journey. The collection illustrates pre-war European art and culture and tells the story of survival and resilience through migration from Vienna to Singapore to Melbourne.



The purchase and use of quality archival materials has helped the organisation to make significant improvements in collections management and accessibility. They are now implementing museum-quality storage systems that provide preventative conservation through proper containment, reduced handling, and protection from dust, light, and damage. Enhanced security measures and updated storage

locations improve disaster planning and damage/loss mitigation. The project creates logical storage arrangements and records that facilitate future collection growth and enable safe behind-the-scenes tours for visitors.

VIC – Carmelite Memorial Library of Spirituality and Mariology – CHG2024/054R

The Carmelite Memorial Library of Spirituality and Mariology received \$7,550 for a Conservation and Collection Management Activities - Carmelite Library Rare Books Collection.

The Carmelite Library is Australia's finest specialised collection in the areas of Christian spirituality and mysticism. The Library belongs to the Australia-East Timor Province of the Carmelite Friars, a Catholic religious order which originated on Mt Carmel in the Holy Land in the late 12th century. The collection began with the arrival of the Carmelites in Melbourne in 1881. Originally a general theological collection, the library now specialises in Carmelitana, Spirituality, and Mariology, and serves students, researchers, and members of the general public. It holds over 50,000 volumes, with approximately 800 comprising the Carmelite Library's rare books collection.

This project has enabled the library to purchase materials so that fragile rare books can be stored appropriately in archival-quality boxes and mylar sleeves, as well as safely displayed. The grant also funded equipment to monitor temperature and humidity conditions, and items to help maintain more stable environmental conditions in the rare book areas. A museum-quality vacuum and other items required for specialised cleaning have been purchased, as well as pest-control products to assist with the eradication of pests like silverfish.

They have also purchased a large wheelie bin and items to stock a disaster recovery kit. This will ensure that in an emergency, they have the resources to respond quickly, minimising potential for damage, and ensuring staff are kept safe while working in potentially unsafe conditions.

Items in the rare books collection will be systematically reviewed by staff, who will improve catalogue records, clean and undertake minor repairs, and store items appropriately. This work is ongoing. At the end of this process, the library will have a definitive list of all rare books, with enhanced catalogue records, which in turn will enhance their discoverability.

NSW – Society of Australian Genealogists – CHG2024/055R

The Society of Australian Genealogists received \$4,377 for a Significant Materials Rehousing and Storage.

The Society was formed in 1932 and is the oldest family history society in Australia. They are an organisation that welcomes enthusiastic amateurs alongside professional genealogists, sharing a passion for family history. Their principal object is the advancement of genealogical education, and this is reflected in their education program and collections.

The Society is managed by a small staff under the direction of a Board of Directors, and they could not open our doors without a dedicated team of volunteers.

Thanks to the grant they purchased a substantial number of enclosures to rehouse the Society's most valuable archive collections items as recommended in the previous Significance Assessment and Preservation Needs Assessment.

The materials purchased will rehouse items from six different accessions: Quong Tart collection (56 items), Caroline Husband collection (23 items), Crommelin papers (218 items), Leila Private Hospital volumes (2 items), and Pye Music volume (1 item), including bound items such as scrapbooks, diaries and registers, letters, manuscript pages and both small and large photographs.

The grant allowed them to purchase storage materials to rehouse all items mentioned above as well as humidity indicator strips for storage areas and nitrile gloves.

TAS – The Royal Society of Tasmania – CHG2024/008R

The Royal Society of Tasmania received \$6,870 for a Conservation project for the Royal Society of Tasmania Art Collection.

The Royal Society of Tasmania was formed in 1843. Their mission is 'the advancement of knowledge'. It is a not for profit organisation, run by a council of volunteers, with one part-time office manager.

The society has an extensive art collection, mainly works on paper, which is housed at the Tasmanian Museum and Art Gallery. It also has a library which is housed at the University of Tasmania. The society produces a peer-reviewed journal 'Papers and Proceedings' annually.

The project was part of the society's ongoing conservation of its art collection. They have previously had the collection valued by a Commonwealth accredited valuer. In his report he singled out one piece in particular that he recommended for conservation – Louisa Anne Meredith's watercolour 'A Cool Debate'. This artwork is considered her most iconic work, however it was in very poor condition, too poor to be displayed. He also considered the artwork was in such poor condition that there was no freelance conservator available to us in Tasmania who was qualified to do the work.

Quotes were sought from three conservators interstate, and International Conservation Services in Sydney was contracted to conserve the artwork.

The conservation work has now been completed, the work has been stabilised and can now be shown to the people of Tasmania.

The Kew Historical Society Incorporated received \$19,375 for a Conservation of the Henty Costume Collection.



The Kew Historical Society was founded in 1958, and is one of the oldest continuing historical societies in Melbourne. For over 60 years, the Society has worked with local government and other organisations to stimulate interest in Kew's history and heritage. The Society is affiliated with the Royal Historical Society of Victoria and the Australian Museums & Galleries Association. Conservation of four outfits from the nationally significant Henty Family Costume Collection, identified as urgently in need of conservation and preservation was the main aim of the project.

Ultimately, volunteers were very satisfied with the outcomes, a number of which provided technical challenges for Grimwade Conservation Services. At the final handover meeting to view the conserved costumes, they felt that their input was valued, and as an organisation they learned much about high level textiles conservation techniques.

The Braidwood & District Historical Society received \$3,905 for a Collection Conservation Project.

The museum was built in 1840 by James Larmer, State Surveyor and is listed on the State Heritage Register. The Society bought the building and formed the Historical Society in 1969.

Members encourage research and enjoyment of their collection. They produce a quarterly Newsletter, and short monthly "Dispatch News Sheet", organise specialised exhibitions, historical tours around the district, give historical talks to schools and organisations, and hold Annual Dinners. They are currently extending the museum to become a Heritage Centre, containing workshops for various old craft skills, and a community space which could be used for conferences.

The grant enabled the conservation of the Jeremiah Jones jacket and hat by Kim Morris of Art and Archival at Queanbeyan. The outfit was moth infested, and the hat and was found by the conservator to be extremely fragile. The volunteers have acquired more knowledge concerning fragile object handling, and the provenance of the items, such as the personal history of Jeremiah and his participation in the Peninsular Wars.

This costume was donated by Jeremiah Jones' family. They have now arranged for the family to come to Braidwood for the unveiling of their families' precious objects. The Historical Society have a very good relationship with Kim Morris and his staff..

QLD – Buderim Historical Society Inc – CHG2024/051N

The Buderim Historical Society Inc received \$16,330 for a Preservation Needs Assessment Implementation, Archival Supplies and Conservation Prioritisation and Mentoring.

Buderim Historical Society Inc (BHS) was formed in 1966 and since 1967 has run a house museum (Pioneer Cottage) in an 1880s house that is state heritage listed.

BHS receives an annual operating grant from the Sunshine Coast Council to enable the museum to be open six days per week, attracting around 1400 visitors per annum. BHS manages a collection of over 3,000 items inclusive of objects and historical documents. This collection is available for public viewing through a link on the BHS website to eHive. In addition, BHS also has a collection of around 1500 images.

Collection Management and Conservation Activities



Key achievements are:

- re-storage of items from the BHS collection, using archival quality materials and the development of custom-made storage boxes and folders
- expanded core of current volunteers and Management Committee that have an enhanced knowledge of collection care and preservation
- professionally described and prioritised list of historically significant objects requiring professional conservation, to enable quotes to be sought from conservators and funding to be sought
- upgraded and/or new skills in cleaning, preservation, storage and safe display, for volunteers directly involved in collection care and curatorial activities
- specific and general display advice that will guide the installation and placement of furniture, objects and new interpretation in each of the museum rooms, following roof replacement in October-November 2025
- increased knowledge of available online resources that will support a more professional approach to condition assessment and cleaning/preservation activities that can be completed by volunteers
- a forward workplan of cleaning and preservation activities that can be conducted by volunteers in the collection care team, to action in the coming year
- updated housekeeping and cleaning procedures
- storage advice for the collection that will continue to be implemented as resources allow/are sourced.

Training

NSW – Lithgow City Council Libraries – CHG2024/007T

Lithgow City Council Libraries received \$5,010 for a preventive conservation of collections, and collection handling and basic paper conservation training.

Lithgow City Council Libraries are a medium sized library service serving a local government area of just over 20,000 people. The local history collection comprises a large variety of items that tell the story of Lithgow's history and the contribution it has made to the industrial history of the nation. The collection comprises, books, photographs, archives, ephemera and objects. It is well utilised by researchers everywhere and is continually growing. Preserving the unique items for the future is the goal of the organisation to ensure it is there for future generations.

The project was based around skills development and a basic knowledge of preservation to ensure that the collections in good condition remain that way. Training was conducted by Tegan Anthes from Collect Preserve over two days in March 2025. Day 1 involved a session on Collections Care and was delivered to 11 participants. Representatives from Lithgow Library, Lithgow Family History Society, Eskbank House Museum, The Glenn Museum and State Mine Museum were in attendance.



Day 2 was primarily aimed at the Lithgow Library collection and the conservation cleaning and handling was demonstrated using these collections. Five library staff primarily involved in the local studies collection and one representative from the State Mine Museum who will be handling and working on similar items were in attendance. The workshops were well delivered by Tegan and all participants over both days reported that they had gained valuable knowledge from the training.
